

Pursuant to the provisions of article 28 of the law 26-03 relating to public offers on the stock market, as amended and supplemented, the Moroccan Securities Ethics Council (CDVM) informs the public that *Charaf Corporation Holding* has filed with the CDVM, on September 16th 2013, a buy-out offer on *FERTIMA* shares.

Following this filing, the CDVM has asked the Casablanca Stock Exchange to suspend the trading on *FERTIMA* shares starting from 17th September 2013.

The aforementioned buy-out offer targets all *FERTIMA* shares that are not held by *Charaf Corporation Holding*. Following the realization of this offer, *FERTIMA* intends to apply for its delisting from the Casablanca Stock Exchange.

Pursuant to the provisions of article 31 of the aforementioned law, the CDVM is allowed a period of 10 working days, from the date of publication of this notice, to decide on the admissibility of the proposed offer.

If the public offer is declared admissible, its main provisions as well as its schedule will be published in a notice of admissibility.

The publication of this notice marks the beginning of the offer period.
